I am committed to investigate health disparities, specifically among forensic and carceral populations, and disseminate practice and policy implications to stakeholders, legislators, and the public. In Fall 2020 I was selected through a competitive process to join the University of Alabama at Birmingham School of Medicine's Minority Health & Health Disparities Research Center (MHRC) as a Health Disparities Research Education Program (HDREP) Scholar. MHRC is supported via multiple NIH grants and my training and mentorship was primarily supported by the Deep South Resource Center for Minority Aging Research (RCMAR) through the National Institute on Aging. This year-long, intensive multidisciplinary program trains junior faculty as health disparities scholars. Scholars are mentored in research training and career development, take courses on bioethics, biostatistics, epidemiology, and minority aging; and participate in an intensive grant writing retreat. For my HDREP grant project, I proposed to study the impact of Cognitive Behavioral Therapy for Pain on people under carceral supervision with co-occurring chronic pain and opioid misuse, with outcomes focused on harm reduction and reduced re-arrest.

I serve as the faculty adviser for a student organization serving students and faculty diagnosed with Attention Deficit-Hyperactivity Disorder. Twice monthly, we meet as a group to discuss strategies for managing ADHD's impact on cognitive functioning and academic performance as well as personal struggles (e.g., organization, self-esteem, impulsive behaviors such as substance misuse and risk-taking sexual behavior). Students often report they feel hopeless at academics and do not consider graduate school as a viable option. I recruit these students into my research laboratory and provide close mentorship to help them achieve their academic and career goals despite challenges posed by ADHD.
